As you may know, our son Gabriel was born in December 2001 with a neural tube defect known as Spina Bifida. As a result, Gabriel spent 7 days in the Neonatal Intensive Care Unit at Rainbow Babies and Children's Hospital (Rainbows) in Cleveland.

Not long after bringing Gabriel home from the hospital, we began to more fully appreciate the enormous debt of gratitude and appreciation we owed the Doctors, Nurses, and staff of Rainbows; most specifically, those affiliated with the Neonatal Intensive Care Unit (NICU).

While appreciating nothing we could do would ever fully express our gratitude, we decided to try any way. In 2002, we started an annual Golf Scramble to raise money for organizations that provide care to critically ill infants and to children with developmental disabilities. In our first six years we have raised over \$84,000 thanks to all of our friends, family, and the business community. Our goal this year is to raise over \$15,000 and we need your help!

Where does the money go?

The mission of the Shining Light Charitable Corp is to raise money to benefit organizations that provide care to critically ill infants and to children with developmental disabilities.
